This report provides ADCR event qualification status for cases involving CAMS alerts related to potential compromise of full magnetic stripe data. Other CAMS alerts (e.g. Law Enforcement "LE" and Recovered Accounts "RA") are not included.

For cases that have met the Qualification Criteria and Eligibility Requirements for ADCR, the GMBS settlement date is provided.

Please note: only accounts and fraud meeting the Qualification and Eligibility Requirements listed below will be eligible for Fraud Recovery and/or Operating Expense Recovery.

¹ The Visa U.S.A. Inc. Operating Regulations were recently changed to expand the scope of the ADCR process to include violations of PCI DSS that could allow a compromise of full magnetic-stripe data. These revisions are effective for qualifying CAMS alerts that occur on or after January 22, 2008. Prior to this change ADCR was limited to compromises involving storage of magnetic-stripe data.
